## **BIO**

Barbara litigates claims on behalf of owners, general contractors and subcontractors in federal and state courts and before arbitral tribunals. Notwithstanding that her training and experience is as a litigator, her principal goal is to assist clients in finding a path to resolve issues, eliminate disputes and to find sensible solutions to complicated legal issues. Separately, in the same vein, she is also trained as a mediator and arbitrator, she is on a current AAA panel, and performs those services when requested either through the AAA or ad hoc.

She also routinely represents government contractors in claims against the federal government. This includes performance and payment bond disputes; representing government contractors in false claims act investigations and disputes; and representing government contractors in bid protests and claims at the various Boards of Contract Appeals and in the Court of Federal Claims.

Barbara graduated magna cum laude from the University of Pennsylvania and received her juris doctor degree from George Washington University. She is admitted to practice in Virginia and the District of Columbia. She co-founded the Women in Construction, Inc. organization, a 501(c)(6) corporation and served as president of the annual conference from 2006 to 2021. She has been on the faculty of the National Institute of Trial Advocacy ("NITA") and also on the faculty of the ABA Division 13 Trial Advocacy Program.
